Mr. Koons stated that the Water and Environmental Sustainability Committee of the Florida Association of Counties recently proposed modeling state water resource investments on the Florida Transportation Commission and Florida Transportation Plan approach for planning, prioritization, a predictable multi-year capital construction program and oversight which reliably delivers transportation improvements.

- XI. EXECUTIVE DIRECTOR REPORT
 - A. Florida Regional Councils Association Monthly Activity Report

Mr. Koons reported that the Florida Regional Councils Association is the statewide organization of the ten regional planning councils. He stated that the Association strengthens Florida's regional planning councils, partners with government and the business community to enhance regional economic prosperity and improves the consistency and quality of regional planning councils programs to ensure they add value to state, regional and local initiatives. Mr. Koons also stated that the Association strives to accomplish these goals by carrying out the activities listed in the December 2021 activity report included in the Council meeting packet. He reviewed the activities listed in the December 2021 report.

B. Florida Regional Councils Association Policy Board Meeting Report

Mr. Koons reported that the Immediate Past Chair Charles Chestnut IV, Former Chair Lorene Thomas, Former Chair Robert Wilford and he attended the semi-annual forum of the Florida Regional Councils Association Policy Board held virtually via communications media technology on January 14, 2022.

Mr. Koons stated the Policy Board heard presentations from Secretary Shawn Hamilton, Florida Department of Environmental Protection and Director Kevin Guthrie, Florida Division of Emergency Management. He also stated the Policy Board also heard reports on proposed building inspection legislation, a sentinel landscape project involving the Avon Park Air Force Range, a statewide water resource investment planning and programming proposal, and received the 2020-21 Florida Regional Councils Association Annual Report. In conclusion, Mr. Koons stated the Policy Board heard a legislative report.

C. 2020-21 Florida Regional Council Association Annual Report

Mr. Koons presented the 2020-21 Annual Report of the Florida Regional Councils Association that was included in the Council meeting packet. He stated the Florida Regional Councils Association is the statewide association of all ten regional councils in Florida. Mr. Koons noted it is governed by a Policy Board made up of three representatives (county, municipal, gubernatorial) from each Council who are in turn advised by the Executive Directors Advisory Committee comprised of all ten executive directors. He stated the following members of the Council currently serve on the Florida Regional Councils Association Policy Board: Charles Chestnut IV, Immediate Past Chair; Lorene Thomas, Past Chair; and Robert Wilford, Past Chair, In conclusion, Mr. Koons stated the activities of the Council are featured on pages 2, 8, 10, 11 and 12 of the annual report.

D. Florida Chamber Foundation ScorecardTM

Mr. Koons reported that the Florida Chamber Foundation has developed the Florida ScorecardTM to provide Florida leaders the metrics needed to secure Florida's future. He stated that the Florida Chamber Foundation's objective to developing a 20-year, statewide strategic plan requires a commitment to measuring our current status and progress toward the stated goals of the Six Pillars 20-year Strategic Plan. Mr. Koons noted that the Scorecard reports metrics for each of the following Six Pillars: Talent and Supply Education, Innovation and Economic Development, Infrastructure and Growth Leadership, Business Climate and Competitiveness, Civic and Governance Systems, and Quality of Life and Quality Places. He reviewed the January 2022 ScorecardTM that was included in the Council meeting packet.

E. Legislative Report

Mr. Koons stated the 2022 Legislature Session convened on January 11, 2022 and is scheduled to adjourn on March 11, 2022. He reported on the status of bills of interest to the Council and member local governments.

F. Florida Job Growth Fund

Mr. Koons reported that the Florida Job Growth Fund is an economic development program designed to build on Florida's success and economic prosperity. He stated in its first year, Fiscal Year 2017-18 (July 1, 2017 to June 30, 2018), the Florida Job Growth Fund provided \$85 million. Mr. Koons stated the Fiscal Year 2021-22 (July 1, 2021 to June 30, 2022) state budget provides \$50 million for public infrastructure and job training projects that support growth and employment in Florida's diverse industries. He noted that public infrastructure projects can include transportation and utilities needed to support economic development.

Mr. Koons stated that, in December 2021, the Big Bend Technical College, located in Perry, received a \$90,000 Florida Job Growth Fund grant award for a Virtual Reality and High Tech Manikin Training Laboratory. He reported that the funds will be used to purchase state-of-theart programmable manikins and virtual reality equipment and software to replicate real-world scenarios to supplement clinical experiences to train nurses and patient care technicians.

XII. COUNCIL MEMBER ANNOUNCEMENTS

Commissioner Wilford, City of Alachua, stated that he will not be seeking re-election to a fourth term in April 2022. He thanked the Council and staff for their support during his tenure as Chair of the Council.

XIII. NEXT MEETING

Chair Demps stated that the next Council meeting is scheduled to be held on February 24, 2022.

RECOMMENDATION:

Authorize the Executive Director to sign an amendment to the memorandum of agreement with Tampa Bay Regional Planning Council for an additional year as a user of the Regional Economic Modeling, Inc., for a fixed fee amount of \$5,530.50.

BACKGROUND:

In 2005, the Council entered into a memorandum of agreement with the Tampa Bay Regional Planning Council to be a user of the Regional Economic Modeling, Inc. economic impact model. The Tampa Bay Regional Planning Council is a licensed user of the model by Regional Economic Modeling, Inc. The Tampa Bay Regional Planning Council is authorized to issue user rights to other parties subject to collection of a fee to be paid to Regional Economic Modeling, Inc. At this time, Tampa Bay Regional Planning Council is proposing to extend the Council's existing memorandum of agreement for a one-year period for a fixed fee of \$5,530.50.

The Regional Economic Modeling, Inc. model is based upon an input-output engine and provides the Council, our local governments, economic development agencies and others with a dynamic tool for economic and demographic analysis and forecasting. It uses national data calibrated for the region, but also can accept local data sets to enhance its accuracy. This model can review system-wide effects over both short- and long-range time horizons, include economic and fiscal impact analyses, policy impact analyses and economic development/redevelopment analyses. The model can be configured to either address the entire region of any number of county-based subsets of the region, as well as including counties in adjacent regions.

Council staff has used this model to evaluate the impact of several projects throughout the region. SUBJECT: Executive Director Speaks at National Infrastructure Bank Coalition Virtual National Forum

On January 27, 2022, Scott Koons, Executive Director, participated on a panel at the National Infrastructure Bank Coalition Virtual National Forum held via media communications technology. He discussed the important connection between infrastructure and regional and national economic prosperity. Mr. Koons highlighted the critical role infrastructure plays in advancing economic productivity and job creation in regions across the nation.

The forum was moderated by Carolyn Barclift, Founder, Build Back Better USA, from Olympia, Washington. Joining Mr. Koons on the panel were the following current and former distinguished state and local elected officials, and infrastructure and macroeconomic policy subject area experts.

The American Society of Civil Engineers and the United States Congress estimates that there is a \$2 trillion shortfall in financing for urgently needed infrastructure. In addition, when broadband, passenger transit, high speed rail, clean water, flood control, energy distribution, ferries, fish passage barriers and power grid upgrades are added an additional \$2 trillion shortfall exists for additional needed infrastructure.

A National Infrastructure Bank would finance projects within all regions of the United States. In the past, the United Stated has employed four national banking systems to build out infrastructure.

The National Infrastructure Bank would perform as a traditional commercial bank and be able to provide financing in the form of loans to states, cities, counties, authorities and multi-state entities to address the infrastructure crisis in the nation. It is estimated that the National Infrastructure Bank would create an estimated 25 million new high paying jobs, increase the tax base and increase the productivity of the entire economy.

Legislation, H.R. 3339, has been introduced in Congress to establish a National Infrastructure Bank to assist in addressing the infrastructure needs of the nation. On June 24, 2021, the Council unanimously adopted Resolution No. 2021-17 requesting the United States Congress to pass legislation to create a National Infrastructure Bank.

SUBJECT: Amendment to Fixed Asset Threshold

RECOMMENDATION:

Increase the minimum value of fixed assets from \$1,000 to \$5,000 for all Council property.

BACKGROUND:

Currently, the Council classifies equipment, fixtures, and other tangible personal property of a nonconsumable and nonexpendable nature with a value or cost which is \$1,000 or more and the normal expected life of which is one year or more as a fixed asset.

The executive director or his designee, as custodian of such property, maintains a record of such property. Once each year, the custodian takes an inventory of property, compares it to the property record and traces and reconciles all discrepancies.

On July 1, 2020, the Florida Department of Financial Services, Division of Accounting and Auditing, amended Florida Administrative Code, Chapter 69I-72.002 State-owned Tangible Personal Property, to increase the minimum value threshold for recording property as fixed assets from \$1,000 to \$5,000 for state agencies. On October 1, 2020, the Florida Department of Financial Services, Division of Accounting and Auditing, amended Florida Administrative Code, Chapter 69I-73.002 Tangible Personal Property Owned by Local Governments, to increase the minimum value threshold for recording property as fixed assets from \$1,000 to \$5,000 for local governments. Based upon this action and the increased cost of equipment, fixtures and other tangible personal property, it is recommended that the Council also increase the minimum value of fixed assets from \$1,000 to \$5,000 for all Council property.

Amend the dollar limits established by the Council for purchasing as indicated in the attached Property, Budget and Fiscal Control Procedures and Policies document, dated February 24, 2022.

BACKGROUND:

Based upon Florida Statutes, Section 287.017, Purchasing Categories, Threshold Amounts, it is recommended that the dollar limits of the various categories of purchasing be amended as stated in the attached Property, Budget and Fiscal Control Procedures and Policies document, dated February 24, 2022. These amendments in thresholds will result in the purchasing procedures of the Council being more efficient.

In addition to the limits that are established by the Council to guide purchasing, written administrative procedures are also in place to follow when seeking proposals for securing consultant services consistent with Florida Statutes, Section 287.55, Consultants' Competitive Negotiation Act.

The limits recommended are adequate and protect the financial interests of the Council consistent with federal and state standards.

PROPERTY, BUDGETARY AND FISCAL CONTROL PROCEDURES AND POLICIES

North Central Florida Regional Planning Council

Effective Date: December 6, 2001 Amended: September 25, 2008 Proposed Amendment: February 24, 2022

- Definition: The word "property" used in these policies means fixtures and other tangible personal property of a non-consumable nature, the value of which is five hundred (\$500) five thousand (\$5,000) dollars or more, and the normal expected life of which is one year or more.
- 1. Bonding: The Council will provide bonding insurance for the Executive Committee and appropriate staff in an amount not less than \$1,000,000 per person.
- 2. Procedure for Signing Checks: All checks shall be signed by a facsimile machine shall be of a type that is secured by two locks, and can be activated only when it is unlocked simultaneously by two keys. The two keys shall be placed in the possession of staff members, selected by the Executive Director, who are not otherwise involved in the accounting operations of the Council, Temporary assignment of the keys to other individuals shall be made by the Executive Director when it is known that the permanent possessor of either of the keys will be out of the office and unavailable to unlock the machine when checks are to be signed.
- 3. Purchasing: The Executive Director, or his designee, shall make purchases to the extent authorized by the budget according to the following procedures:
 - A. Less than \$2,499 \$5,000- Outright Purchase
 - B. **\$2,500 \$9,999 \$5,000 to less than \$20,000** Telephone Quotes (3), or purchase under State Contract
 - C. **\$10,000 \$24,999 \$20,000 to \$35,000** Written Bids (3), or purchase under State Contract
 - D. \$25,000 and over Over \$35,000- Advertised Sealed Bids with Executive Committee approval or purchase under State Contract. If award is over \$50,000 \$65,000, a Competitive Bid Report is presented to the Council for approval unless the purchase is made under State Contract. The Council will also be advised of any purchase made for \$50,000 \$65,000 or more.
 - E. Upon determination by the Executive Director that it is in the best interest of the Council, services, supplies and materials may be obtained from governmental entities in those instances covered by Items A, B, and C, and upon concurrence by the Executive Committee, in those instances covered by Item D.
- 4. Invoice Payment: The Executive Director, or his designee, will approve vouchers for payment.
- 5. Equipment Leasing: The Executive Director may lease equipment to the extent authorized by the budget; however, lease agreements requiring a commitment of funds for more than one budget year shall be approved by the Council.

- 6. Disposal of Property: Property declared by the Council to be surplus may be disposed of by the following procedures:
 - A. Contribution, upon request, to other local government entities or non-profit, charitable organizations;
 - B. Request the City of Gainesville or Alachua County to sell property on behalf of the Council at an advertised sale at which similar city or county property is being sold.
 - C. Publicly advertise for sealed bids for surplus property valued at **more than \$500 five thousand dollars (\$5,000) or more** with acceptance of most favorable proposal to the Council by the Council.
 - D. Approval, by the Executive Committee, on an item-by-item basis, proposals by individuals or organizations to purchase surplus property valued at less than \$500 five thousand dollars (\$5,000) when it is concluded that the disposal of such items by any other acceptable method would be excessively expensive.
 - E. Destroy surplus property determined to have little or no resale value.







SUBJECT: Legislative Report

The 2022 Legislature Session convened on January 11, 2022 and is scheduled to adjourn on March 11, 2022. The legislative interim Committee schedule was, as follows:

- Week of September 20, 2021
- Week of October 11, 2021
- Week of October 18, 2021
- Week of November 1, 2021
- Week of November 15, 2021
- Week of November 29, 2021

The following paragraphs provide a summary of bills of interest.

REGIONAL PLANNING COUNCIL FUNDING

The Governor did not recommend any funding for regional planning councils for Fiscal Year 2022-23.

LOCAL ORDINANCES

Senate Bill 280 by Senator Hutson authorizes courts to assess and award reasonable attorney fees and costs and damages in certain civil actions filed against local governments; requires a board of county commissioners to prepare a business impact estimate before the enactment of a proposed ordinance; and requires a governing body of a municipality to prepare a business impact estimate before the enactment of a proposed ordinance. Referred to Community Affairs Committee; and Rules Committee. Passed by Community Affairs Committee (Yeas 6, Nays 2). Passed by Rules Committee (Yeas 14, Nays 2). Passed by Senate (Yeas 28, Nays 8).

House Bill 403 by Representative Giallombardo and Morales authorizes courts to assess and award attorney fees and costs and damages in certain civil actions filed against local governments; requires local governments to prepare business impact statement before adoption of proposed ordinances; specifies requirements for posting and content of statement; requires counties and municipalities to suspend enforcement of certain ordinances subject of certain legal actions; requires courts to give priority to certain cases; and specifies factors court must consider in determining whether ordinance is arbitrary or unreasonable; and provides declaration of important state interest. Referred to Local Administration and Veterans Affairs Subcommittee; Civil Justice and Property Rights Subcommittee; and State Affairs Committee. Passed by Local Administration and Veterans Affairs Subcommittee. Passed by Civil Justice and Property Rights Subcommittee. **This bill is now in State Affairs Committee**. Legislative Report Page 2

LOCAL GOVERNMENT

Senate Bill 620 by Senator Hutson authorizes certain businesses to claim business damages from a county or municipality if the county or municipality enacts or amends certain ordinances or charter provisions; authorizes businesses to recover costs and fees in a specified manner and if certain requirements are met; requires courts to consider certain factors and follow specified guidance when assessing costs; specifies requirements for the courts in determining and awarding attorney fees; and requires attorneys and businesses to submit certain documentation relating to attorney fees. Referred to Judiciary Committee; and Appropriations Committee. Passed by Judiciary Committee (Yeas 7, Nays 4). Passed by Appropriations Committee (Yeas 11, Nays 7). Passed by Senate (Yeas 22, Nays 14).

House Bill 569 by Civil Justice and Property Rights Subcommittee and Representative McClure authorizes businesses to claim business damages from county or municipality if county or municipality enacts or amends certain ordinances or charter provisions; requires presuit procedures; authorizes recovery of costs and fees; specifies evidence relating to mediations and negotiations is inadmissible; and requires courts to consider certain factors and follow specified guidance. Referred to Civil Justice and Property Rights Subcommittee; Local Administration and Veterans Affairs Subcommittee; and Judiciary Committee. Passed by Civil Justice and Property Rights Subcommittee. This bill is now in Judiciary Committee.

ECONOMIC DEVELOPMENT

Senate Bill 800 by Senator Albriton authorizes municipalities to exempt by ordinance the public service tax that specified users would pay on electrical energy purchases; provides an exemption from the state tax on sales, use, and other transactions for building materials used in the rehabilitation of real property in an opportunity zone; revises the qualification criteria and tax credit amounts for new and existing businesses under the Rural Job Tax Credit Program; and establishes a rural opportunity tax refund program for qualified target industry businesses in rural areas. Referred to Commerce and Tourism Committee; Finance and Tax Committee; and Appropriations Committee. Passed by Commerce and Tourism Committee (Yeas 10, Nays 0). Passed by Finance Committee (Yeas 7, Nays 0). This bill is now in Appropriations Committee.

House Bill 685 by Representative Drake and Morales authorizes charges for natural gas or propane used by qualified businesses in opportunity zones to receive specified sales tax exemption; revises criteria to qualify for Rural Job Tax Credit Program; removes match requirement from Rural Community Development Revolving Loan Fund; increases percentage of grants Florida Department of Economic Opportunity may award; requires specified percentage of State Economic Enhancement and Development Trust Fund be used for affordable housing; creates Florida Microfinance Corporation; provides purpose, powers, and duties of corporation; creates board of directors; specifies powers of board; requires appointment of president of corporation; requires board to create Florida Microfinance Corporation Guarantee Account; and requires annual report to Florida Department of Economic Opportunity. Referred to State Affairs Committee; Ways and Means Committee; Infrastructure and Tourism Appropriations Subcommittee; and Commerce Committee. Passed by Infrastructure and Tourism Appropriations Subcommittee. Passed by State Affairs Committee. This bill has been laid on the table by rule. Legislative Report Page 3

AFFORDABLE HOUSING

Senate Bill 962 by Senator Bradley authorizes counties and municipalities, respectively, to approve certain mixed-use residential development projects subject to certain conditions; and provides that approval for an affordable housing development or a mixed-use residential development project is self-executing. Referred to Community Affairs Committee; Transportation Committee; and Rules Committee. Passed by Community Affairs Committee (Yeas 8, Nays 0). Passed by Transportation Committee (Yeas 8, Nays 0). Passed by Rules Committee (Yeas 15, Nays 1). Passed by Senate (Yeas 39, Nays 0).

House Bill 981 by Representative Payne authorizes counties and municipalities to approve certain mixeduse residential developments using specified approval process; and provides that approval for affordable housing development or mixed-use residential development is self-executing. Referred to Local Administration and Veterans Affairs Subcommittee; and State Affairs Committee. Passed by Local Administration and Veterans Affairs Subcommittee. Passed by State Affairs Committee. This bill is now on the calendar for second reading by the House of Representatives.
