

## I. INVOCATION, PLEDGE OF ALLEGIANCE AND INTRODUCTIONS

Chair Spooner called the meeting to order at 7:32 p.m. with an invocation given by Commissioner Patterson and a pledge of allegiance to the flag. Chair Spooner stated that there was a quorum.

Chair Spooner welcomed and introduced Thomas Hawkins, past Council member and Alachua County ADCO member, David Pieklik, from Nature Coast Business Development Council and Levy County ADCO member, Tim Bennett, City Manager for the City of Madison, Joe Riddick, past member and former Council Chair from Bradford County and Diana Davis, wife of Council member Mayor Davis.

Chair Spooner asked that Item VI.A., Executive Committee Appoint members for two-year terms to the North Central Florida Areawide Development Co., Inc., Item VI.B.2., Clearinghouse Committee City of Hawthorne Adopted Amendment and Item VI.B.3. Clearinghouse Committee City of Gainesville Draft Amendment, these items were received by staff after the meeting packets were distributed, be added to the committee reports.

- ACTION: Commissioner Poe made the motion, with a second by Commissioner Hutchinson to add Item VI.A., Executive Committee Appoint members for two-year terms to the North Central Florida Areawide Development Co., Inc., Item VI.B.2., Clearinghouse Committee City of Hawthorne Adopted Amendment and Item VI.B.3. Clearinghouse Committee City of Gainesville Draft Amendment to the committee reports. The motion carried unanimously.
- II. PRESENTATION ON TRANSPORTATION DISADVANTAGED PROGRAM IN NORTH CENTRAL FLORIDA

Scott Koons, Executive Director, introduced Lynn Franson-Godfrey, Senior Planner, for the Transportation Disadvantaged. Ms. Franson-Godfrey gave a presentation concerning the activities of the Council relating to the Transportation Disadvantaged Program in north central Florida. Chair Spooner thanked Ms. Franson-Godfrey for her presentation.

Mr. Koons reported that the Articles of Incorporation of the small business loan company, the North Central Florida Areawide Development Co., Inc., require that the Council make appointments of its members. These appointments are to be made on even numbered years for two-year terms.

Chair Sandra Haas gave the Clearinghouse Committee report. She stated that the Clearinghouse Committee met earlier in the evening and reviewed three local government comprehensive plan amendments.

Ms. Haas stated that the Committee found that the local government comprehensive plans, as amended, were not anticipated to result in significant adverse impacts to regional

> facilities, Natural Resources of Regional Significance or adjoining local governments. Ms. Haas stated that the Clearinghouse Committee recommended forwarding these findings to the local governments and the Florida Department of Economic Opportunity as regional comment.

ACTION: Ms. Haas made the motion, with a second by Commissioner Poe, to approve the Clearinghouse Committee recommendation concerning Item #1 Columbia County Comprehensive Plan Draft Amendment, Item # 2 City of Hawthorne Comprehensive Plan Adopted Amendment and Item #3 City of Gainesville Comprehensive Plan Draft Amendment. The motion carried unanimously.

## VII. EX-OFFICIO MEMBER REPORTS

Russell Simpson, Florida Department of Environmental Protection, stated that Northeast District staff will be holding a Hazardous Waste training in there office in Jacksonville on November 5, 2014.

Brian Delburn, Florida Department of Transportation, stated that in November 2014 the Department will be attending Board of County Commissioners meetings in rural counties to discuss potential projects for the Department Tentative Five-Year Work Program.

## IX. EXECUTIVE DIRECTOR'S REPORT

A. Florida Regional Councils Association Monthly Activity Report

Mr. Koons reported that the Florida Regional Councils Association is the statewide organization of the 11 regional planning councils. The Association strengthens Florida's regional planning councils, partners with government and the business community to enhance regional economic prosperity and improves the consistency and quality of regional planning councils programs to ensure they add value to state, regional and local initiatives. He stated that the accomplishments of the Association's Director of Intergovernmental Affairs, Sheri Coven, are reported each month to the Council. He also highlighted several of the accomplishments listed in the September 2014 monthly review report included in the Council meeting packet.

B. Florida Chamber Foundation Scorecard<sup>TM</sup>

Mr. Koons stated that the Florida Chamber Foundation has developed the Florida Scorecard<sup>TM</sup> to provide Florida leaders the metrics needed to secure Florida's future. The Florida Chamber Foundation's objective to develop a 20-year, statewide strategic plan requires a commitment to measuring our current status and progress toward the stated goals of the Six Pillars 20-year Strategic Plan. He further stated that the Scorecard reports metrics for each of the Six Pillars benchmarked to the other 49 states. The Six Pillars are Talent Supply and Education, Innovation and Economic Development, Infrastructure and Growth Leadership, Business Climate and Competitiveness, Civic and Governance Systems and Quality of Life and Quality Places. He reviewed the October 2014 Scorecard<sup>TM</sup> included in the Council meeting packet.

### C. National Association of Regional Councils Award

Mr. Koons stated that the National Association of Regional Councils serves as a national voice for regionalism by advocating for regional cooperation as the most effective way to address a variety of community planning and development opportunities and issues. He also stated that the National Association of Regional Councils member organizations are composed of multiple local governments that work together to serve American communities, large and small, urban and rural. Mr. Koons stated that for nearly 50 years, the National Association of Regional Councils has represented the interests of its members and has advanced regional cooperation through effective interaction and advocacy with Congress, Federal officials and other related agencies and interest groups. He stated the National Association of Regional Councils focus includes, but is not limited to, transportation and the economic and community development, environment, homeland security and regional preparedness, and a variety of community issues undertaken by its member organizations.

Mr. Koons stated that at the National Association of Regional Councils 48th Annual Conference and Exhibition, the North Central Florida Regional Planning Council received the 2014 Medium Metro Achievement Award. The Association recognized the Council for developing a standard set of reporting that was used for the preparation coordinated statewide comprehensive economic development strategies prepared by each of the 11 regional planning councils in Florida, serving as U.S. Department of Commerce designated economic development districts. He also stated the project was recognized for having significant impact on regional cooperation, coordination and excellence.

E. Check Fraud Status Report

Mr. Koons reported that on March 20, 2013, a fraudulent check in the amount of \$49,523.00 that was written on the Council's bank account was processed and paid by Wells Fargo. Also on March 20, 2013, Council staff filed an affidavit of check fraud concerning this matter with Wells Fargo. On March 25, 2013, Council staff filed a crime report concerning this matter with the Gainesville Police Department. On April 18, 2013, the Council Attorney sent a letter to Wells Fargo requesting that Wells Fargo remit to the Council within 30 days the unauthorized \$49,523.00 released by Wells Fargo from the Council's account. He added that on June 3, 2013, attorneys for Wells Fargo responded via letter stating that Wells Fargo will not reimburse the Council for the \$49,523.00 released from the Council's account by Wells Fargo.

Mr. Koons stated that at their meeting on July 25, 2013, the Council authorized the Council Attorney to file a lawsuit against Wells Fargo to recover the unauthorized \$49,523.00, to engage Stanley Cushman from the law firm of Scruggs and Carmichael to serve as co-counsel for the lawsuit and to designate Scott Koons, Executive Director, as the Council's representative concerning all matters related to such lawsuit. He stated that on August 6, 2013, a lawsuit was filed against Wells Fargo to recover the Council's funds.

Mr. Koons further reported that on September 9, 2013, Wells Fargo responded to the complaint by filing a Motion to Compel Arbitration. Council Attorney Wershow and Co-Counsel Stanley Cushman responded to the motion stating that arbitration does not apply to the dispute and have filed a motion for a hearing on the motion to compel arbitration.

A hearing originally scheduled for October 30, 2013 in the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida on the Motion to Compel Arbitration filed by Wells Fargo to resolve the dispute between the Council and Wells Fargo was rescheduled for January 24, 2014. Mr. Koons reported that at the conclusion of the hearing, the Circuit Court granted the Motion to Compel Arbitration.

Mr. Koons reported that a letter was sent to Wells Fargo on May 13, 2014 requesting additional information concerning the disputed check. On September 24, 2014 a Notice of Arbitration and Statement of Claim was filed with the American Arbitration Association by Co-Counsel Stanley Cushman on behalf of the Council. On October 14, 2014 attorneys from Wells Fargo filed a Respondent's Answering Statement to the Statement of Claim.

Mr. Koons further reported that Council Attorney Wershow and Co-Counsel Stanley Cushman are continuing to coordinate with the attorney of Wells Fargo on the selection of an arbitrator and scheduling of the arbitration hearing.

## F. Employee Retirements

Mr. Koons informed the Council that two employees will be retiring on October 31, 2014. He stated that Tony Marshall, Finance Director, who has been employed by the Council for 10 years, will be retiring. He then stated that Carol Laine, Executive Assistant to the Executive Director, who has been employed with the Council for 28 years, will also be retiring. He then informed the Council that a new hire, John Theimann, will begin serving as Finance Director on October 27, 2014 and Jean Strong will be promoted to the position of Executive Assistant to the Executive Director and will begin serving in that capacity starting November 3, 2014.

Chair Spooner informed the Council that the next Council meeting will be held on December 11, 2014 at the Holiday Inn Hotel & Suites in Lake City. The meeting was adjourned at 8:05 p.m.

SUBJECT: Second Amended Agreement with Florida Division of Emergency Management for Additional Training Funds for Hazardous Materials Emergency Preparedness -Fiscal Year 2013-2014

## **RECOMMENDATION:**

Authorize the Chair to execute a second amended agreement with the Florida Division of Emergency Management for an additional amount of \$4,450 in training funds to conduct four additional classes, on behalf of the North Central Florida Local Emergency Planning Committee, for Fiscal Year 2013-14.

## BACKGROUND:

The Florida Division of Emergency Management passes through funds from the United States Department of Transportation for hazardous materials planning and training. The Council, on behalf of the North Central Florida Local Emergency Planning Committee, offers free hazardous materials response training to local government employees.

Training funds for Fiscal Year 2013-14 have been spent on conducting 18 hazardous materials emergency response classes. An additional \$4,450 has been requested to conduct four additional classes prior to December 31, 2014. This includes classes in Cross City, Live Oak and Perry.

Review of these items is currently delegated to staff with the Clearinghouse Committee providing oversight review of staff comments.

The proposed amendment also authorizes staff to schedule, arrange and conduct scoping meetings for sector plans pursuant to Section 163.3245(2), Florida Statutes, as amended. In addition, the proposed amendment also includes a number of editorial changes to the Clearinghouse Committee Procedures.

## NORTH CENTRAL FLORIDA REGIONAL PLANNING COUNCIL POLICY 1998-2; AMENDED 11-1-00 <u>AND PROPOSED AMENDMENT 12-11-14</u> CLEARINGHOUSE COMMITTEE PROCEDURES

The North Central Florida Regional Planning Council has been designated by the state **land planning agency** as the regional planning agency to exercise certain review responsibilities under Chapters 163, 186, and 380, Florida Statutes, **as amended**, for Administrative District III including the counties of Alachua, Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Madison, Suwannee, Taylor, and Union.

Council **Rule 29C-1, Florida Administrative Code, Procedures** establishes the Clearinghouse Committee as a standing committee of the Council having the responsibility of preparing recommendations on each of the individual review items for final action by the Council.

The Committee's regular meetings will be held in conjunction with immediately prior to the regular monthly Council meetings beginning at 6:00 or 6:30 p.m. and concluding at 7 p.m. depending on the number and/or type of review items. The Chairman may call special meetings from time to time as may be necessary to carry out the responsibilities of the Committee. Notice of meetings shall be in accordance with the requirements of Chapter 120, **F.S Florida Statutes**. The Committee will follow Robert's Rules of Order except where specified otherwise.

## GAS PIPELINES, ELECTRIC TRANSMISSION LINES AND ENVIRONMENTAL IMPACT STATEMENTS

The Clearinghouse Committee is assigned the responsibility of reviewing and preparing recommendations to the Council regarding Environmental Impact Statements, gas pipeline applications, electric transmission line applications and electrical power generating plants equal to or exceeding 75-megawatts in capacity applications. The Clearinghouse Committee shall review said items for adverse effects on regional resources or facilities identified in the strategic regional policy plan and extrajurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the region.

<u>The Clearinghouse Committee is given the responsibility of preparing a report and</u> <u>recommendation to the Council on said items, and presenting its findings to the Council for</u> <u>final action.</u>

# INTERGOVERNMENTAL COORDINATION AND REVIEW (IC&R) PROCESS

Established and governed by Presidential Executive Order 12372 and Gubernatorial Executive Order **83-150** <u>95-359</u>, the **IC&R Intergovernmental Coordination and Review** process attempts to ensure the compatibility of federal or federally funded projects with local, regional and state plans and programs through a 30-day review process. The Council has been designated by the state as the regional clearinghouse for Administrative District III. Due to their relatively small size/scope, nearly 100 percent <u>all</u> of the applications for federal assistance and/or proposed federal projects received for review affect or have the potential to affect only small (local) areas.

Staff is assigned the responsibility of processing proposed projects submitted to the Council for review with the Committee providing oversight of staff reviews at regular intervals. On receipt, staff forward copies of the project description to potentially impacted local governments-**and government** agencies for their review and comments which, once received, are forwarded to the State Clearinghouse, the single point of contact (for federal agencies) for the state. Based on the comments received, staff makes a determination of the consistency of the proposed project with local and areawide plans and programs.

Copies of the project description, along with staff findings and local comments, are reviewed by the Committee at its regular monthly meeting.

## DEVELOPMENTS OF REGIONAL IMPACT <del>(DRI)</del> AND FLORIDA QUALITY DEVELOPMENT <del>(FQD)</del> REVIEW PROCESSES

The Council has been designated by the state as the regional planning agency for Administrative District III for purposes of implementing Section 380.06, **F.S <u>Florida Statutes</u>**. The Council's responsibilities in this review process are strictly governed by the statute and rules adopted by the State Land Planning Agency, currently the Florida Department of **Community Affairs Economic Opportunity**.

The Clearinghouse Committee is given the responsibility of preparing the report and recommendation required by the statute and rule, and present it to the Council for final action.

The staff is authorized to schedule, **and** arrange **and conduct DRI** preapplication conferences **for Developments of Regional Impact** and determining when the application for development approval, application for development approval of a substantial deviation, application for development designation, and application for development designation of a substantial change, are sufficient to begin their respective review processes.

## LOCAL GOVERNMENT COMPREHENSIVE PLAN AND PLAN AMENDMENT REVIEWS

Section 163.3164(5), F.S. <u>163.3184(3) and (4)</u>, Florida Statutes, establishes a requirement that proposed local comprehensive plans and amendments to the plans be reviewed for <del>potential</del> impacts to regional resources and facilities and adjacent local governments. Once the plans/amendments are adopted by the local governments, the plans as a whole are to be reviewed for overall consistency with the adopted strategic regional policy plan for the regional planning district within which the local governments reside. <u>adverse effects on regional resources or facilities identified in the strategic regional policy plan and extrajurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the region.</u>

The Clearinghouse Committee is assigned the responsibility of reviewing both the draft and adopted plans/amendments and preparing a recommendation for consideration of the Council which takes final action. However, **the** Committee is delegated the responsibility of forwarding comments to the Department of **Community Affairs Economic Opportunity** and the local governments on those proposed or adopted plan amendments which require action prior to the regularly-scheduled meetings of the Council.

Reports submitted in accordance with this delegation will be included as "information" items on the agenda of the next regularly-scheduled meeting of the Council.

## OTHER REVIEW AND COMMENT REQUESTS

All other items, including electric utility ten-year site plans, sent to the Council for review and comment shall be processed in the same manner as IC&R Intergovernmental Coordination and Review requests with the exception of campus master plans prepared in accordance with Section 240.155(3), F-S Florida Statutes. Campus master plans shall be processed in the same manner as local government comprehensive plan reviews.

City item CPA 14-01 amends the text and the Future Land Use Plan Map of the City Comprehensive Plan based on an evaluation completed by the City to reflect changes in state requirements pursuant to Section 163.3191, Florida Statues; amends the text of the Land Use Element; the Transportation Element; the Housing Element; the Public facilities Element; the Conservation Element; the Recreation and Open Space Element; the Intergovernmental Coordination Element; the Capital Improvements Element; and the Public School Facilities Element (see attached excerpts).

#### 1. ADVERSE EFFECTS TO SIGNIFICANT REGIONAL RESOURCES AND FACILITIES IDENTIFIED IN THE STRATEGIC REGIONAL POLICY PLAN

The City is bisected by the following roads which are identified and mapped in the North Central Florida Strategic Regional Policy Plan as part of the Regional Road Network: U.S. Highway 301, State Road 16, State Road 100 and State Road 230. Nevertheless, significant adverse impacts are not anticipated to occur to the regional road network as a result of the amendment since it does not result in an increase in intensity or density of use. Additionally, the Transportation Element adds several policies which implement Transportation Planning Best Practices contained in the regional plan (see attached).

Significant adverse impacts are not anticipated to occur to Natural Resources of Regional Significance as no such resources are located within or near the City.

# Since 2010, Florida's Private Sector Businesses Created 651,300 Jobs for Florida Families

DID YOU KNOW? Florida job creators added 12,800 private-sector jobs over the month of September which helped lower Florida's seasonally adjusted unemployment rate to 8.1%, down two basis points to one of the lowest since the recession began. Nine of the ten major industries across Florida experienced positive over the year job growth through September, with only government employment showing a decline over the year. As we project forward to 2030, population growth and demographic changes are going to play a big part in Florida's future workforce. Based on <u>Florida Chamber Foundation</u> estimates, we will need to create close to two million net new jobs across the state to maintain a six percent unemployment rate. SUBJECT: National Association of Development Organizations Innovation Award

The National Association of Development Organizations is a Washington, D.C.-based association that promotes programs and policies that strengthen local governments, communities and economies through regional cooperation, program delivery and comprehensive strategies. The Association's Innovation Awards program recognizes regional development organizations and partnering organizations for improving the economic and community competitiveness of local communities throughout the region.

The Association recently awarded the North Central Florida Regional Planning Council a 2014 Innovation Award. The award was for the North Central Florida Regional Transportation Study. The 2014 slate of awardees includes 100 projects representing the Association of members from 27 states.

Each year, the Association recognizes member organizations that demonstrate innovative approaches to regional economic and community development with an Innovation Award. More than 1,400 Association member projects have been recognized since 1986 for their creative efforts in advancing economic development. The breadth and scope of the winning projects is impressive and far reaching and illustrates the important role the Association of members have across their regions, as well as on the national landscape.

#### North Central Florida Regional Transportation Safety Study

At the 2014 National Association of Development Organizations Annual Training Conference, the North Central Florida Regional Planning Council, in cooperation with partner organization the Metropolitan Transportation Planning Organization for the Gainesville Urbanized Organization, received a 2014 Innovation Award. The Association recognized the Council for developing a method to use geographic information system data to evaluate the success of safety improvements on the highway system. The Council provides staff services to the Metropolitan Transportation Planning Organization for the Gainesville Urbanized Area. In December 2013, Council staff completed a technical report for the Metropolitan Transportation Planning Organization entitled Incorporating Safety into Transportation Planning.

A primary purpose of this technical report was to strengthen the foundation for identifying and solving safety issues in the Long Range Transportation Plan. This was accomplished through the analysis of motor vehicle crashes on the road network, and presentation of various strategies and countermeasures to improve safety. The process was data-driven and has measurable performance measures.

By using up-to-date, geocoded accident data combined with the spatial analysis only available from a Geographic Information System, the results achieved from safety improvements are data-driven and have measurable performance measures. This level of analysis provides a very timely feedback on identifying safety issues in potential long range transportation planning projects as well as providing decision makers with measurable feedback on the impacts of recently completed projects.

SUBJECT: Check Fraud Status Report

On March 20, 2013, a fraudulent check in the amount of \$49,523.00 that was written on the Council's bank account was processed and paid by Wells Fargo. Also on March 20, 2013, Council staff filed an affidavit of check fraud concerning this matter with Wells Fargo. On March 25, 2013, Council staff filed a crime report concerning this matter with the Gainesville Police Department.

On March 28, 2013, Council Attorney Jonathan Wershow and Council staff briefed the Executive Committee concerning this matter. On April 18, 2013, the Council Attorney sent a letter to Wells Fargo requesting that Wells Fargo remit to the Council within 30 days the unauthorized \$49,523.00 released by Wells Fargo from the Council's account. On April 25, 2013, Council staff briefed the Council concerning this matter. On June 3, 2013, attorneys for Wells Fargo responded via letter to Mr. Wershow's letter stating that Wells Fargo will not reimburse the Council for the \$49,523.00 released from the Council's account by Wells Fargo.

On July 25, 2013, the Council authorized the Council Attorney to file a lawsuit against Wells Fargo to recover the unauthorized \$49,523.00 and designate Scott Koons, Executive Director, as the Council's representative concerning all matters related to such lawsuit. In addition, the Council authorized the Council Attorney and the Executive Director to contact federal and state law enforcement agencies to discuss the fraudulent check processed and paid out of the Council's bank account by Wells Fargo.

On August 5, 2013, Council Attorney Wershow and I met with Mr. William Cervone, State's Attorney for the Eighth Judicial Circuit of Florida to discuss the check fraud incident. Mr. Cervone offered the assistance of his staff to work with the Gainesville Police Department to secure the bank records relating to the check fraud incident.

On August 6, 2013, Council Attorney Wershow and Co-Council Stanley Cushman filed a five-count lawsuit in the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida, against Wells Fargo Bank, N.A. to recover the unauthorized \$49,523.00 released by Wells Fargo from the Council's bank account.

On September 9, 2013, Wells Fargo responded to the complaint by filing a Motion to Compel Arbitration. Wells Fargo alleges that disputes related to the Council's checking account are to be resolved by an arbitrator. Council Attorney Wershow and Co-Counsel Stanley Cushman responded to the motion stating arbitration does not apply to the dispute.

A hearing was scheduled for October 30, 2013 in the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida on the Motion to Compel Arbitration filed by Wells Fargo to resolve the dispute between the Council and Wells Fargo. However, the hearing was rescheduled for January 24, 2014. At the conclusion of the hearing, the Circuit Court granted the Motion to Compel Arbitration.

A letter was sent to Wells Fargo on May 13, 2014 requesting additional information concerning the disputed check. On September 24, 2014 a Notice of Arbitration and Statement of Claim was filed with the American Arbitration Association by Co-Counsel Stanley Cushman on behalf of the Council. On October 14, 2014 attorneys from Wells Fargo filed a Respondent's Answering Statement to the Statement of Claim.

Council Attorney Wershow and Co-Council Stanley Cushman are continuing to coordinate with the attorney of Wells Fargo on the selection of an arbitrator and scheduling of the arbitration hearing.
