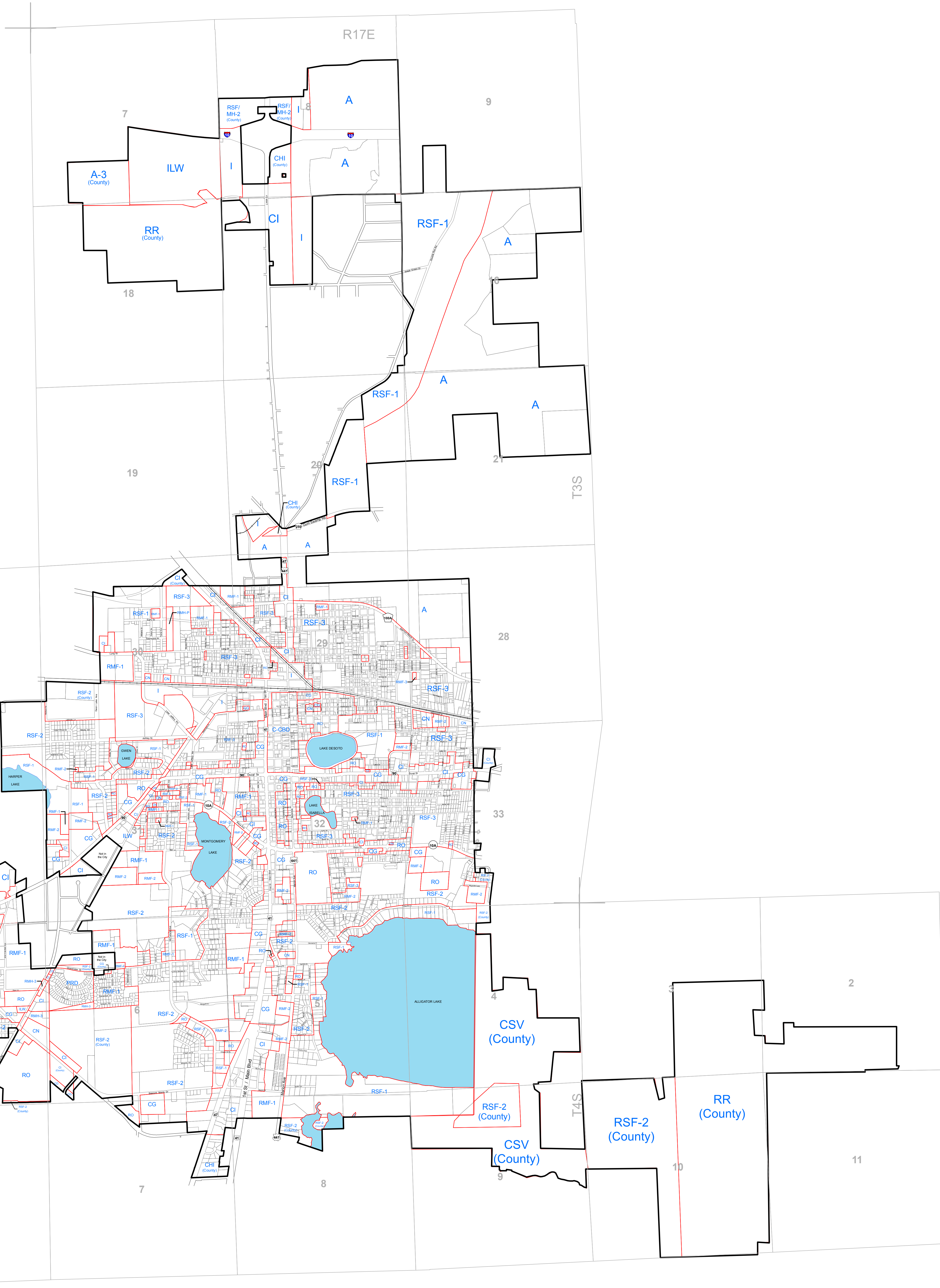

Official Zoning Atlas

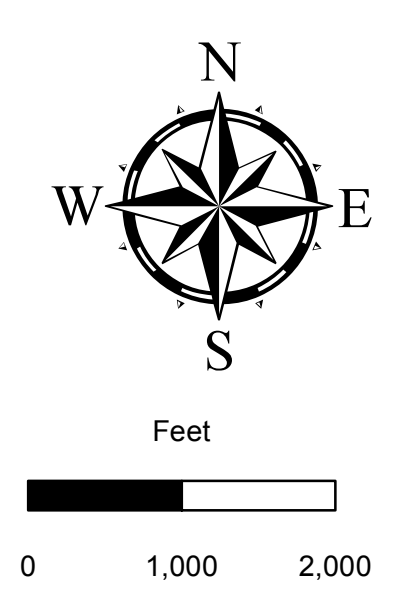
