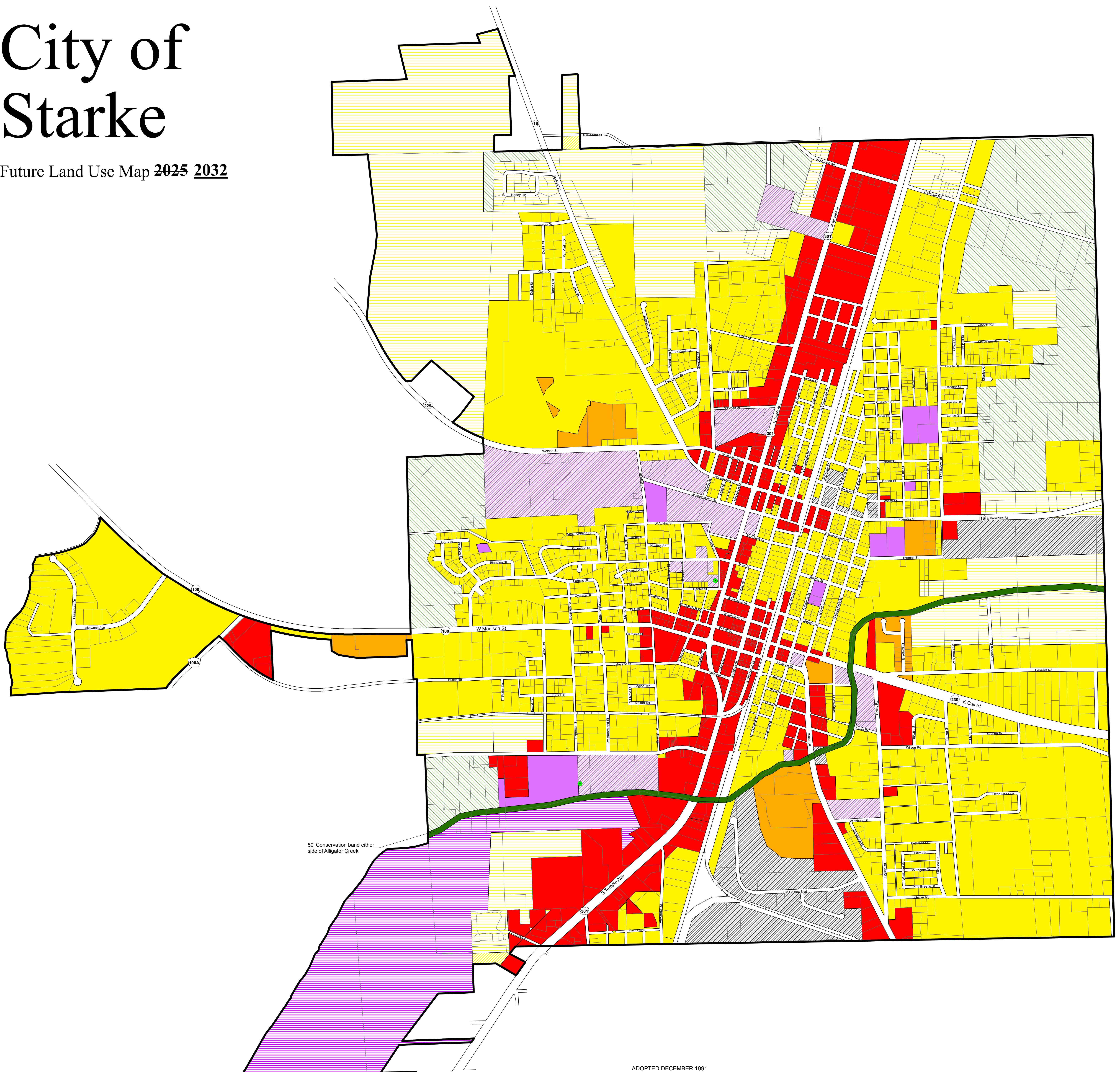

Future Land Use Map **2025** 2032

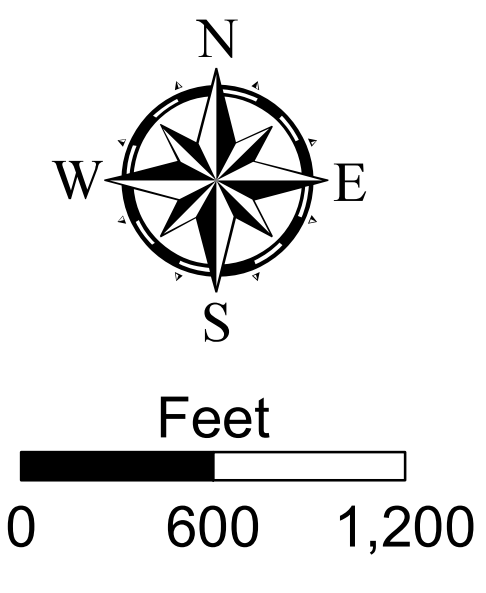


FUTURE LAND USE PLAN MAP CLASSIFICATIONS
