





#### New Potential Violations and Areas of Concern:

#### **Checklist Independent Potential Violations and Areas of Concern**

Type: Violation

Rule: 273.13(d)(1)

#### Explanation: Spent fluorescent tubes were not in closed, properly labeled boxes.

Corrective Action: In order to return to compliance, the facility should contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions. Containers should be labeled with one of the following phrases: "Universal Waste Lamps(s)," "Waste Lamp(s)," or "Used Lamp(s)."

Rule: 62-710.401(6)

Explanation: The facility's used oil tank is not double walled or located within secondary containment.

Corrective Action: No further action is required. The facility constructed a 350-gallon secondary containment structure around the used oil tank. The structure is in a photograph in an email dated May 23, 2011.

Explanation:	<ol> <li>The facility improperly disposed of F005 hazardous waste rags by throwing them into the trash.</li> </ol>
	2). The facility's drum of D001/D018/D035/D039/F003/F005 hazardous waste paint was open, allowing the solvent to evaporate.
Corrective Action:	<ol> <li>In order to return to compliance, the facility should handle rags contaminated with Autoguard Brake Cleaner as F005 hazardous waste, use laundered shop rags that are cleaned through a linen service, or use a solvent that is non-hazardous on a rag.</li> </ol>
	2). No further action is required. The facility is in compliance per a May 23, 2011 email.
