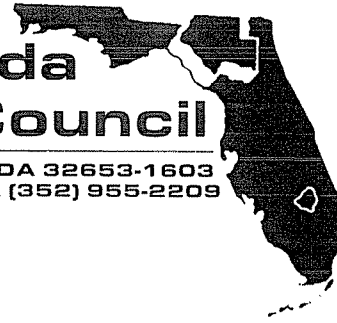

Dinner will start at 7:00 p.m. and the meeting at 7:30 p.m.

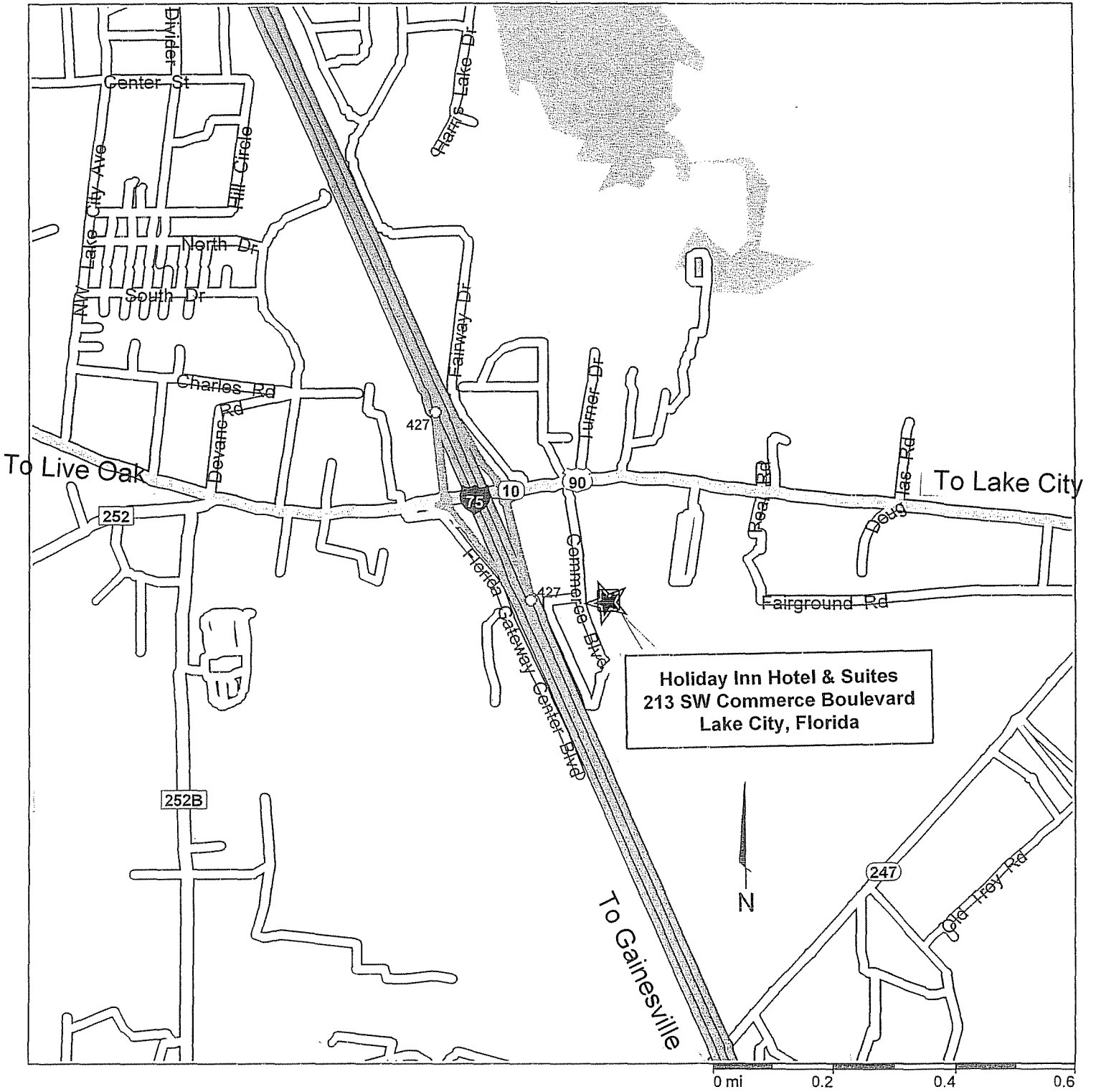

(Location Map on Back)

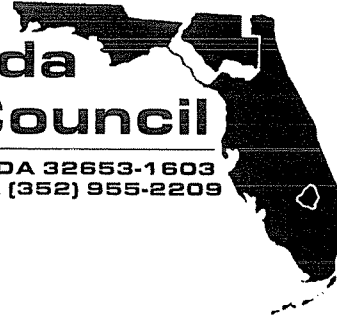
