(Location Map on Back)

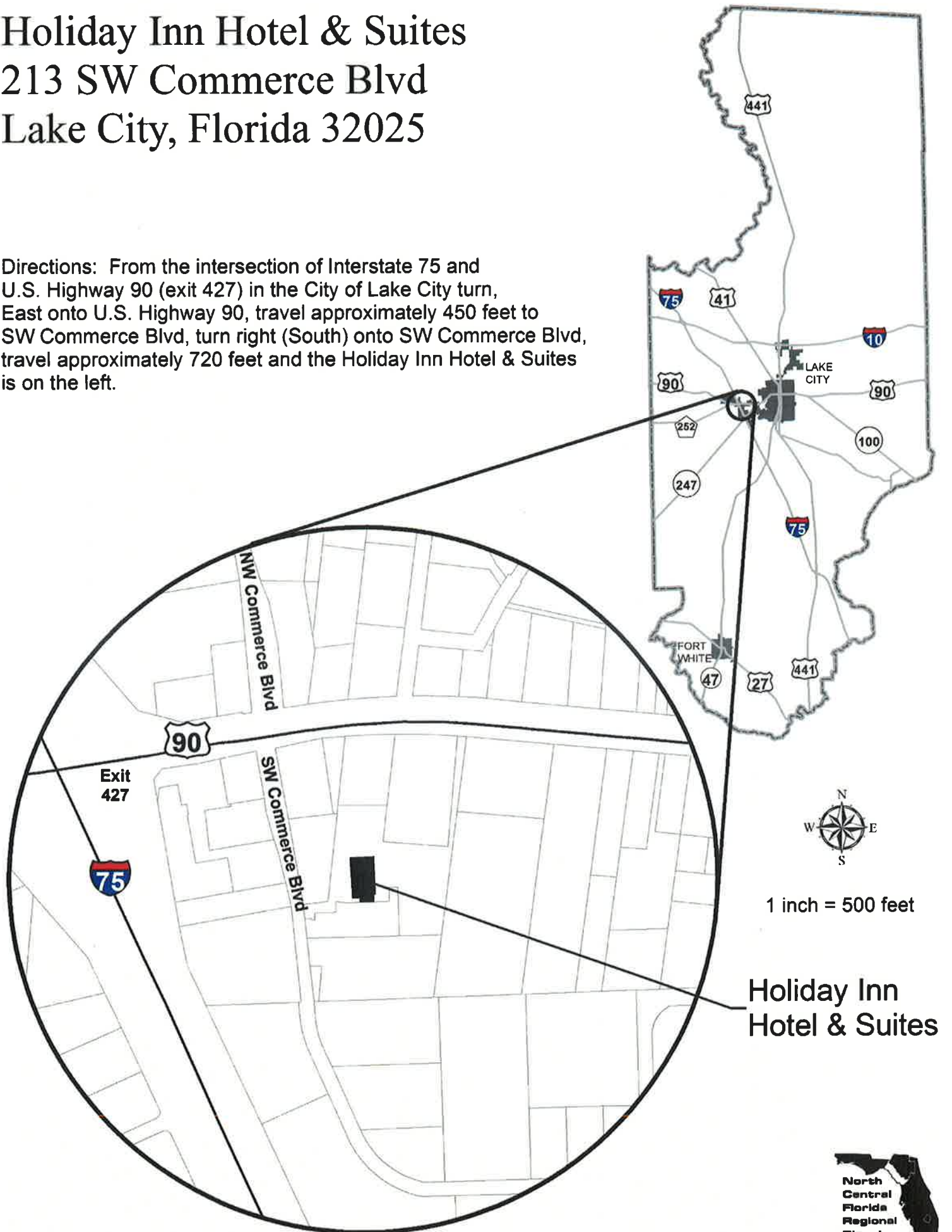
