#### CALL TO ORDER

#### I. INTRODUCTIONS

Introductions were done at the request of Vice Chair Brinkman.

#### II. APPROVAL OF THE MEETING AGENDA

Vice Chair Brinkman asked for approval of the meeting agenda.

## ACTION: James Samec moved to approve the meeting agenda. Harvey Budd seconded; motion passed unanimously.

#### III. APPROVAL OF COMMITTEE MINUTES

## ACTION: Sharon Hawkey moved to approve the January 30, 2008 minutes. Sheryl Conner seconded; motion passed unanimously.

#### IV. CHAIRMAN'S REPORT

Vice Chair Brinkman announced that the next MTPO meeting is scheduled for March 13<sup>th</sup> at 3:00 p.m. in the Jack Durrance Auditorium. He said that the CAC's next meeting is scheduled for March 26<sup>th</sup>. He noted that there was an additional agenda item.

Mr. Michael Escalante, MTPO Senior Planner, requested that the agenda be amended to add item VII.B US 441 Bikelanes for a CAC recommendation to the MTPO.

## ACTION: Sharon Hawkey moved to amend the meeting agenda to add agenda item VII.B US 441 Bikelanes. Ewen Thomson seconded; motion passed unanimously.

#### V. SW 62<sup>ND</sup> BOULEVARD CONNECTOR

Mr. Escalante stated that the County's consultant was prepared to discuss the corridor alternatives for the SW 62<sup>nd</sup> Boulevard Connector and interim projects.

Ms. Jennifer Spagnoli, Alachua County Traffic Engineer, stated that several SW 62<sup>nd</sup> Boulevard Connector alternatives were reviewed by MTPO and County Advisory Committees. She noted that the MTPO, at its December meeting, approved the evaluation criteria and analysis of Alternatives 1 - 4.

Mr. Terry Shaw, HNTB Project Manager, discussed the SW 62<sup>nd</sup> Boulevard Connector corridor alternatives and proposed interim priority projects and answered questions.

Mr. Escalante reported the Bicycle/Pedestrian Advisory Board and Technical Advisory Committee recommendations for the SW 62<sup>nd</sup> Boulevard Connector corridor alternative.

#### ACTION: Sharon Hawkey moved to recommend that the MTPO approve Alternative #1 (Exhibit 1) and the three Interim Priority Projects (Exhibit 2). Tom Reilly seconded. Ewen Thomson moved to divide the motion; it was accepted by Ms. Hawkey and Mr. Reilly.

#### **SPLIT ACTION PART ONE:**

Sharon Hawkey moved to recommend that the MTPO approve Alternative #1 (Exhibit 1). Tom Reilly seconded; motion passed 7 to 6.

#### **SPLIT ACTION PART TWO:**

Sharon Hawkey moved to recommend that the MTPO approve the three Interim Priority Projects (Exhibit 2). Tom Reilly seconded; motion passed unanimously.

#### VII.B US 441 BIKELANES

Mr. Escalante stated that the MTPO Chair received a letter from FDOT indicating that US 441 from Archer Road to NW 23<sup>rd</sup> Avenue would not be restriped for bikelanes as part of the US 441 Resurfacing Project.

- ACTION: Ruth Steiner moved to recommend that the MTPO request that FDOT provide a wide outside curblane consistent with the current striping of the travel lanes on US 441 (from Archer Road (State Road 24) north to NW 23<sup>rd</sup> Avenue (State Road 120)) as part of the Year 2009 resurfacing project. Ewen Thomson seconded; motion passed 11 to 2.
- ACTION: Chandler Otis moved to recommend that the MTPO request that FDOT install ramps to the sidewalks to allow access/egress for bicyclists on the US 441 bridge over NW 8<sup>th</sup> Avenue in order to compensate for the road narrowing. Ruth Steiner seconded; motion passed 12 to 1.
